SI. The school is directed to ensure that: No.

- The total number of sections of Bal Vatika shall be restricted to 03 (01 section each for Bal Vatika-1, 2 & 3 respectively). The total number of sections from classes I to X shall be restricted to 12. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq. ft. dimension. The number of students in each class shall be restricted to 40.
- The ownership of the land is not clear from the land certificate uploaded by the school. As per the certificate, land is owned by Mrs. N. Rajeshwari. It has, however not been made clear in the said land certificate as to how the individual got the ownership i.e. by way of Sale deed/Gift deed/Conveyance deed/Allotment letter etc. School is directed to obtain the revised land certificate with all relevant details and submit compliance within 03 months in SARAS portal.
- Fire NOC/ fire safety certificate dated 16.11.2022 uploaded on SARAS portal does not have date of its validity. It can not be perpetual. School is directed to obtain the revised certificate with all relevant details and submit compliance within 03 months in SARAS portal.
 - The composite science lab has not been properly laid out. Biology section has been seen in a separate room. School should have arranged all three science specific sections i.e. Physics, Chemistry & Biology in a single room/lab. Utilities like water & gas connections are to be provided in the work stations itself. The school shall upgraded the lab as per Board's SoP with proper stone/metal topped work stations and permanent fixture, washbasin, water & gas connection in the workstations, storage facilities, seating arrangement and safety features such as fire extinguishers and exhaust fan within 03 months and submit the compliance with videography.

- The school does not seem to have referred to RPwD Act and guidelines of the Board for CwSN toilets. Regular cubicles have been converted into CwSN toilets, which are too small and narrow for free movement of wheelchair/walker. The building is G+1, but one CWSN toilet each for boys and girls is seen in the video. The School shall construct CWSN toilets separately for boys and girls on every floor with proper permanent signage, indicating the floor number and with all infrastructural facilities, as per norms of RPwD Act and guidelines of the Board within 03 months and submit the compliance with videography.
 - 6 The school shall ensure the training of its teachers with CoE Chennai within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any

- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
